GENERAL SESSION MEETING – MID WINTER CONFERENCE SATURDAY, FEBRUARY 2, 2019

WEST GATE LAKE RESORT, ORLANDO, FLORIDA

Opening ceremonies were held to include the Prayer and Pledge of Allegiance to the Flag.

STATE COMMANDER DANNY ANDERSON stated we had a great joint opening session and hopes that the joint openings can continue in the future. Commander Anderson then recognized National Jr. Vice-C-I-C Hal Roesch, and National Council Member Benny Bachand. Commander Anderson also recognized Past Department Commanders. Commander Anderson also recognized National Council member Al Lipphardt from Georgia.

NATIONAL COUNCIL MEMBER BENNY BACHAND stated that the National Council is there to make sure we are represented within the organization. Benny then thanked everyone for all that they did at the services for Past Department Commander Jack Carney who passed away earlier this year.

NATIONAL REPRESENTATIVE JR. VICE COMMANDER-IN-CHIEF HAL ROESCH spoke about a funeral for a very special comrade-Rosemary Mariner-who was the Navy's first tactical pilot. Hal stated that the services were being held today in Tennessee and the Navy would be doing a fly over as a tribute to her. Hal then spoke briefly on Blue Water Navy which recognizes those that weren't on the ground exposed to Agent Orange. Hal then stated that moving forward there is going to be a schedule implemented for Departments to be inspected by National. Hal stated that at this time inspections are only at post and district levels. Hal spoke about how this inspection process will hold Departments more responsible.

MILITARY ORDER OF THE COOTIE GRAND COMMANDER GARY GODARD spoke about how important the MOC is. Gary reported that since June the Hospital report states that there was over \$81,000 raised. The Military Order of the Cooties is the honor degree of the Veterans of Foreign Wars bringing smiles to those in beds of white.

ADJUTANT/QUARTERMASTER GENE PERRINO made a motion to accept the minutes to the Council of Administration meeting held on Friday, October 26, 2018 as published on the Department website, motion seconded by Chief of Staff Mike Clinesmith, Motion passed.

Motion made by Gene Perrino to accept the minutes to the General Session held on Saturday, October 27, 2018 as published on the Department website, motion seconded by State Sr. Vice Commander Tony Purdy, motion passed.

General Session Meeting Minutes

STATE CHAPLAIN HARRY SEILER stated that so far this year nursing home and hospital visits are -313; cards that have been given out are 191; flag presentations are 51 and memorial services performed is 77. Harry stated that we are doing the work and getting the exposure which is a great thing. Harry then stated that he will head up the Memorial Service at the National Convention and he is asking if anyone would like to volunteer to help hand out church brochures on Sunday morning to please see him.

STATE INSPECTOR DON BULT stated that seventeen posts still have not turned in or corrected their audits. Don also stated that the audit form online must be opened through Adobe Reader for it to work. Don spoke about inspections needing to be done by February 28th, and you have until March 31st to fix and submit and discrepancies. Don also stressed that posts are exempt from sales tax on beverage and food only; you still have to pay sales tax on everything else and file a DR15 form.

STATE LEGISLATIVE DIRECTOR KURT SCHUH stated that our conference in Washington DC is coming up in the beginning of March. Kurt stated in the past month he met with the Orlando Hospital Center and talked about VA issues. Kurt also spoke about Congressman Brian Mast and talked how he is a hero and will be speaking at the banquet. Kurt stated that he is working to get disabled veterans plates for veterans that are disabled 50% or greater and for a small fee all these veterans could have one. Another thing Kurt spoke about were parking signs in the city, state and county for veterans to be able to park. Kurt stated if we can get parking signs in the city, state and county it may urge businesses to do the same. Kurt stated that Guide Star teaches you how to be part of a nonprofit. There are 45,000 veteran nonprofits registered and in Florida there are 2,223 and sixty five percent of nonprofits are from the American Legion and the VFW. In stating this Kurt urged everyone to be sure they are reporting things, since this is how we are recognized.

MEMBERSHIP DIRECTOR KURT SCHUH stated that we are at 91.45% right now and we have jumped almost 2% since January. The goal is 97% by the end of March and Kurt stated we can meet this goal.

VETERANS SERVICE OFFICE DIRECTOR JASON SMITH addressed the Blue Water Navy stating that this was a very important court decision that affects tens of thousands of veterans. Jason stated they would like to start putting in claims for anyone that could be eligible if you feel that you meet the requirements. He also urged everyone to get the word out there to people that could be eligible but are unaware of the decision. Jason stated that he would be available after the meeting for anyone that would like to start a claim.

BECAUSE WE CARE CHAIRMAN DAVE HARRIS stated that when an application is filled out it needs to be signed by the Quartermaster or Commander or Service Officer to be accepted and we need to give all the information that we possibly can. Such as proof of military service so you are sure the individual was in the military and that we are giving to veterans. Dave also stressed that female veterans go through the same things as the male veterans and many time they also have children. Dave also touched on the Touch 7 Crisis Line and stated he has seen it work and it is a wonderful program. Dave thanked everyone for their support and donations were taken at this time.
